re. Public complaint of Greek Police officer Spyros Nino - orders for murders in Greece.

Ambassador Fragiskos Kostellenos,

Mr. Spyros Ninos is an officer of the Greek Police with expertise in counter-terrorism, with action in the secret services of Greece (NIS), and for 15 years in charge of the security of the Mitsotakis Family, and the Prime Ministers of Greece, who in a radio and television interview, proceeded with revelations about the criminal activity of famous, political figures he knows by saying the following:

"Someone has to speak, Mareva (Prime Minister's Wife), gave the order to kill you (addressed to journalist Stefanos Chios, don't you know that?" The Greek Police officer Spyros Ninos told journalist Stefanos Chios who has been the victim of an attempt murder, remains unsolved to this day, like many other murders involving political figures, subjects-interests.

As is known throughout Greece, on July 28, 2020, an assassination attempt was made against the journalist Stefanos Chios, outside his home. The journalist shot twice, one bullet hit the victim in the neck and the other bullet in the chest, but was literally saved by a miracle.

After the above public complaints, a few days later the 38-year-old Dimitris Ninos, son of Greek Police officer Spyros Ninos, is murdered with a 9mm bullet shoot to the head.

The f. officer of the Greek Police Spyros Ninos in the same public complaint gave the names of those ordering for murders in Greece.

"Dimitriadis offered me money to kill people", revealed the Greek Police officer Spyros Ninos, who, after refusing, said that he also had at his disposal (USB) sticks with the controversial conversations of the Prime Minister's nephew with underworld mobsters.

Let's remember that Grigoris Dimitriadis, in addition to being the nephew of the Prime Minister Kyriakos Mitsotakis, was the Secretary General of the Greek Government, at the same time he was the political leader, responsible for the country's secret services (NIS), who resigned after the disclosure of the illegal surveillance of Greek politicians with the use of the Predator system together with Panagiotis Kontoleontas Commander of the secret services (NIS) of the country.

In the same televised show with his testimony, the f. Greek Police officer Spyros Ninos, complaining, emphasized that "the Prime Minister's wife pulls all the strings at all levels", Mitsotakis cannot be unaware of all this" and he continued, "Mareva Grabovski ordered the murder of Chios, Dimitriadis executed it with the mafia thugs. I left because I could not serve murderers."

Because, I have a vested interest in the observance of the law in Greece and by extension in Denmark as being a permanent resident, consequently the European Union.

I have reasonable questions, of which demanding the Greek competent authorities, in particular requesting the Greek Ministry of Justice, Ministry of Internal Affairs and the Minister of Development & Investments to provide duly answers.

**The Questions:**

What is the law in Greece for?

A reasonable question that should be answered by Mr. Isidoros Dogiakos, the Chief Prosecutor of the Supreme Court of Greece, before he escapes from this position in the next weeks in accordance to information.

Why The Chief Prosecutor of the Supreme Court of Greece when murders and murderers are reported does nothing for those crimes?

Those crimes harm the highest value, which the Penal Code is called to protect, the constitutional order itself, the law and the chief prosecutor of the Supreme Court in Greece where unfortunately in the company of the current prosecutors as Pharisees - "Blind guides - those straining out the gnat and swallowing the camel" this is how the Greek Mafia of politicians and businessmen in Greece acts unhindered, resulting in families mourning their murdered members.

I remind you that my request for your answer is in conformity to the common values for all EU Member States, Rule of Law, The Treaty on European Union as it is enshrined in Article 2., known as the Copenhagen criteria, established by the Copenhagen European Council in 1993 and strengthened by the Madrid European Council in 1995.
